WEIGH-IN

Will be conducted by each boat. Each two person (boater and non-boater) team are also fishing for themselves as part of their six-man team. In addition, if their two-man team weight is the greatest of all the other two-man teams fishing this event, they will also qualify for the Bonus Pot.

Remember that this is a six-man team event.

Sharing fish between members and anyone else is strictly prohibited. No team is allowed to

switch partners after the entry form has been turned in to UEABA. (fish with who you signed-up with and weigh-in with same person)

At no time during this tournament will any team be allowed more than a five fish limit per boat.

TEAMS

A club may bring as many six-man teams as they would like.

A club is also permitted to fish with less than six-men but must still pay the full entry amount of \$600.00 to do so.

BONUS POT

If an contestant fishes alone and qualifies for the Bonus Pot, they will be awarded the entire amount if they should win the tournament.

BLAST-OFF/DISCOUNTS

Launching of boats sequence will be determined by the date of the non-refundable deposit was received by UEABA. All entries that are received before October 1st and are paid in full will qualify for a 10% discount.

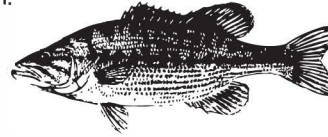

Dead Fish Penalty

A penalty of 2 ounces per fish will be assessed for each dead fish found in the livewell or brought to the scales for the weigh-in.

Rules and Regulations

These guidelines, as set fourth on this entry form will be strictly followed. It is each contestants responsibility to read and fully understand these rules, as contestants will be disqualified for non-compliance and forfeit all prize money and entry fees. All contestants agree by signing this entry form that the decision of the tournament director will be final in all respects.

Boats/Motors and Safety

Any boat may be utilized if it meets all state and local requirements. All boats must have an adequate live well with aeration. Coast Guard approved life vest must be worn and fastened while boat is on plane. All boats must have a working ignition kill switch attached to the driver while boat is being operated. In the event of mechanical failure or an emergency situation, contestants may transport their catch to the weigh-in site by way of another contestants boat.

Sportsmanship

No fishing is allowed from outside your boat at any time or within 50 yards of another anchored or tied boat which has a trolling motor in the stored position without the expressed permission of its occupants. Any contestant displaying poor sportsmanship, breaking state or local laws or in violation of the rules of this tournament trail will forfeit their entry fee and may be disqualified [at the discretion of the tournament director] from this event and all future events sponsored by United East Atlanta Bass Anglers

Drugs and Alcohol

Narcotics and alcoholic beverages may not be consumed during practice or tournament hours. Anyone who might be required to take a drug prescribed by a physician must report it to UBAA tournament officials prior to the tournament

Tackle and Trolling

Only one reel and rod combination may be used at any time. Each cast must be completed [cast and reeled in] before another cast is attempted or made. Only artificial baits may be used [pork rind trailers are the only exception]. Trolling with the combustion motor is not allowed.

Publication Rights

By signing this entry form, all contestants agree to allow UEABA the exclusive rights to take and publish photographs, video and audio of them as contestants. Use this material or dispose of it, in any legal manner without furthur permission or compensation to the contestant.

Pre-Fishing and Guides

There are no off-limit days for the tournament. Guides may be hired prior to tournament day, but you cannot fish with them or follow them during tournament hours. Guides who have taken pay for their services on the tournament lake may not enter the tournament as a contestant.

Species of Bass

Only largemouth, smallmouth and spotted bass will weigh. All fish must be a minium of 14 inches. Any short fish [less than 14 "] will result in the loss of the entire SIX MAN TEAMS largest fish in weight. Fish measure with closed mouth using The Golden Rule measuring device.

Polygraph and Protest

All leading contestants will automatically be subject to one or more polygraph test. The same will apply to both parties involved in written protest which are officially reported no later than 15 minutes after the final tournament weigh-in. The numbers of the supposed offenders must accompany all protest. Failure to clear or agree to the ruling of an official polygraph test will result in disqualification, loss of entry fees and the loss of any winnings.

Ties

In the event of a tie between two or more contestants the winnings will split of that and the next place.

Prize Money

Contestants must understand agree that prize money to be paid may be adjusted according to the total number of teams.

Competitors

Contestants must be at the official weigh-in site at the appointed time or will be automatically disqualified.
